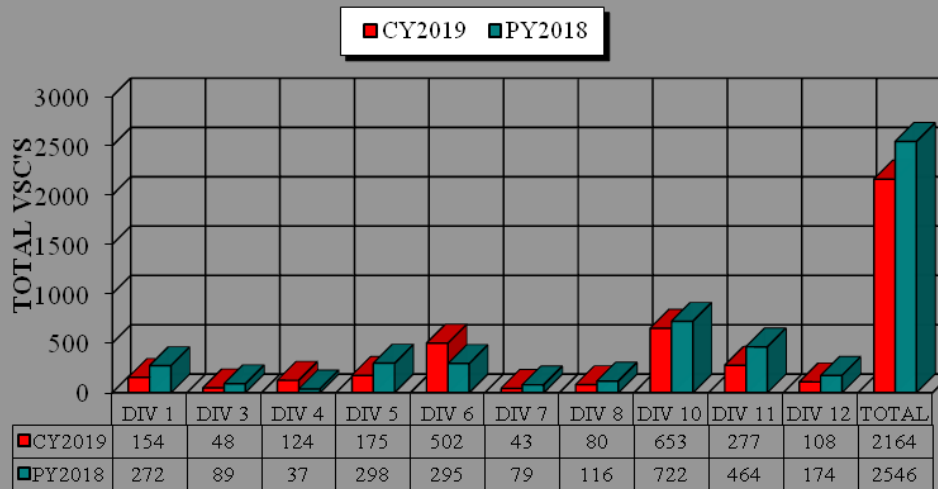

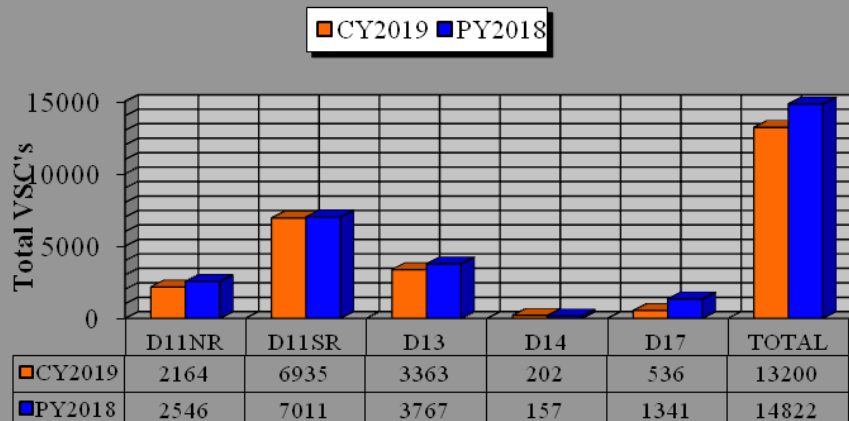

PAC AREA VSC's Thru August 5, 2019



The 2019 goal for D11NR is 5,000 VSC's. We are 43% of our goal for the year and 85% of 2018 production at this time. The data source is AUXINFO*. Additional stats from AUXINFO* indicates that 1,949 or 90% have passed the VSC, 942 or 43% are First Time VSC's, and 890 or 41% are High Risk VSC's. In addition 642 Paddlecraft VSC's have been performed, which is approximately 30% of our total VSC production. We currently have 200 ACTIVE Vessel Examiners(VE's)*

-**ANSC#3004** - DECAL, CANOE, KAYAK, SUP OR ROWBOAT (ORANGE) (BR) - Vessel Identification Sticker - (IF FOUND - CONTACT). Weatherproof stickers provide room for the vessel owners name and two phone numbers emergency responders need when paddle craft are found adrift without an operator. **(MAX 50)**

-**ANSC#3004a** - PAMPHLET, BE SMART, BE SAFE HAVE FUN (BR) - A beginner's guide to safer paddling - Always wear your life jacket - Know your limits - Carry the paddling essentials. **(MAX 100)**

-**ANSC#3004b** - PADDLE TIP REFLECTOR KIT - A reflective waterproof decal label kit. One sheet contains four shiny reflective stickers for paddle tips and a sticker for identification for the kayak and owner. **(MAX 50)**



-**There have been** several questions regarding The Auxiliary-America's Boating Club(U.S. Power Squadron) reciprocity agreement dated March 2018. -**Please** pass the word that once again the Vessel Examiner class is coming to PCA Fair over the weekend of September 21st-22nd. This class will provide an excellent opportunity for new members to get involved with the Vessel Safety Check (VSC) program in the Auxiliary and help rebuild our Vessel Examiner base. This will be a 2-day class that includes a video, power-points, and complete text review for the member and the final exam on Sunday. The member is required to bring a copy of the VSC Manual and review the material prior to class. A copy of the VSC Manual is available for download on the D11NR Vessel Examiner website: <http://rbsafety.d11nuscgaux.info/ve.html>.

-**Just** a reminder, per the 2015 Vessel Examiner (VE) workshop, paddlecraft VSC's DO **NOT** count toward the initial VE qualification or requalification. The VSC may be performed a sailboat, powerboat or PWC.

-Our Vessel Examiner (VE) active database has dropped to 200 active examiners, with **101** in REYR. The active total is approximately 13% of our D11NR membership.

-**A special request** from the Director's office; PLEASE have the qualifying members 7038 with the 5 VSC's entered into AUXDATA by the FSO/SO-IS **PRIOR** to submission of the MT-2 to the Director's office.

-**NEW-VSC's ON RENTALS-**At the request of Commodore Kirkwood, and after 18-years, the VSC Rental Program has been updated for 2019 and moving forward.

ANYONE who performs rental VSC's on PWC's, fishing boats, houseboats, paddlecraft, etc. needs to be aware of the new changes after 1 June 2019. Please go to the D11NR Vessel Examiner (VE) website: <http://rbsafety.d11nuscgaux.info/ve/ve.html> and review ML-1 thru ML-5 and closely review and follow the instructions as **ALL** of these forms have been revised and approved by DCO Kirkwood.

Any 2019 currently signed agreements will be acceptable, but a copy must be emailed or mailed to the DSO-VE. Billy Ray, ADSO-VE will be administering this program, but if you have any questions, please don't hesitate to contact me.

-This is a reminder that if you have not completed the Introduction to Risk Management course #100202 by 30 April 2019, you are now in REYR.

You must take the course to be removed from REYR status before any credit can be given for your VSC activities. The course is not a pass or fail course, and it takes 90 minutes and using AUXLMS will automatically record the course. If you've never logged into AUXLMS, here is a link to instructions and video:

Please do not delay if you plan to participate in NSBW activities. If you require additional assistance, please contact your FC or FSO-MT.

-For Coast Guard liability insurance purposes, **PRIOR** to leaving the house for **ANY** VSC activity other than to participate at an organized station, **PLEASE** remember to notify member of the flotilla leadership (FC, VFC, and FSO-VE) of your planned activity. The notification could be in the form of an email, text message or a phone call. In the unlikely event of an incident, be prepared to provide proof of the notification. In addition, per the new VSC Manual please remember, you also need to be in uniform and if boarding a vessel you need to be wearing a lifejacket.

-PLEASE do NOT wear boots to climb aboard a vessel to perform a VSC. Our program allows for deck shoes, white or black tennis/walking with soft soles. If this is not an option, please consider purchasing disposal shoe/boot covers available at any the paint or hardware dept. or at Wal-Mart, Lowes, Home Depot, etc. A package of 6 is typically under \$10.
