



PAC AREA VSC's Thru September 3, 2019



The 2019 goal for D11NR is 5,000 VSC's. We are 58% of our goal for the year and 73% of 2018 production at this time. The data source is AUXINFO*. Additional stats from AUXINFO* indicates that 2,595 or 89% have passed the VSC, 1,200 or 41% are First Time VSC's, and 1,081 or 37% are High Risk VSC's. In addition 1,002 Paddlecraft VSC's have been performed, which is approximately 35% of our total VSC production. We currently have 200 ACTIVE Vessel Examiners(VE's)*

VSC Questions

-These are actual questions from VE Exam Version "E" dated 2014. Answers can be found in another location in the report.

1. How do you determine a boat's length if the registration or other paperwork doesn't have that information?

- Measure from end to end over the deck excluding sheer.
- Measure from stem to stern and subtract seven feet.
- Take the width and multiply by 3.14.
- Step it off—each step should be about three feet.

2. Certain gear on a vessel must be Coast Guard, S.A.E. or U.L. approved to be eligible for a VSC decal. Which items are these?

- Life Jackets (PFDs), VDSs, Fire Extinguishers, First Aid Kits, Anchors.
- Life jackets (PFDs), Fire Extinguishers, First Aid Kits, Navigation Lights, MSDs.
- VDSs, Life Jackets (PFDs), Fire Extinguishers, Backfire Flame Arresters, MSDs.
- VDSs, Fire Extinguishers, Backfire Flame Arresters, MSDs, Navigation Lights.

-**ANSC#3004** - DECAL, CANOE, KAYAK, SUP OR ROWBOAT (ORANGE) (BR) - Vessel Identification Sticker - (IF FOUND - CONTACT). Weatherproof stickers provide room for the vessel owners name and two phone numbers emergency responders need when paddle craft are found adrift without an operator. **(MAX 50)**



-**ANSC#3004a** - PAMPHLET, BE SMART, BE SAFE HAVE FUN (BR) - A beginner's guide to safer paddling - Always wear your life jacket - Know your limits - Carry the paddling essentials. (MAX 100)

-**ANSC#3004b** - PADDLE TIP REFLECTOR KIT - A reflective waterproof decal label kit. One sheet contains four shiny reflective stickers for paddle tips and a sticker for identification for the kayak and owner. (MAX 50)

-**There have been** several questions regarding The Auxiliary-America's Boating Club(U.S. Power Squadron) reciprocity agreement dated March 2018. This memorandum states each vessel examiner member (Auxiliary or Power Squadron) when completing vessel examinations or instructing. The memorandum brings unity to both programs; please remember that you can't double - count the vessel examinations or instructor hours. -**Please** pass the word that once again the Vessel Examiner class is coming to PCA Fair over the weekend of September 21st-22nd. This class will provide an excellent opportunity for new members to get involved with the Vessel Safety Check (VSC) program in the Auxiliary and help rebuild our Vessel Examiner base. This will be a 2-day class that includes handouts, a video, power-points, and complete text review for the member and the final exam on Sunday. The member is required to bring a copy of the VSC Manual and review the material prior to class. A copy of the VSC Manual is available for download on the D11NR Vessel Examiner website: <http://rbsafety.d11nuscgaux.info/ve.html>.

-**Just** a reminder, per the 2015 Vessel Examiner (VE) workshop, paddlecraft VSC's DO **NOT** count toward the initial VE qualification or requalification. The VSC may be performed a sailboat, powerboat or PWC.

-**Our Vessel Examiner (VE) active database has dropped to 200 active examiners, with 101 in REYR. The active total is approximately 13% of our D11NR membership.**

-**A special request** from the Director's office; PLEASE have the qualifying members 7038 with the 5 VSC's entered into AUXDATA by the FSO/SO-IS **PRIOR** to submission of the MT-2 to the Director's office.

-**NEW-VSC's ON RENTALS**-At the request of Commodore Kirkwood, and after 18-years, the VSC Rental Program has been updated for 2019 and moving forward. **ANYONE** who performs rental VSC's on PWC's, fishing boats, houseboats, paddlecraft, etc. needs to be aware of the new changes after 1 June 2019.

-This is a reminder that if you have not completed the Introduction to Risk Management course #100202 by 30 April 2019, you are now in REYR.

You must take the course to be removed from REYR status before any credit can be given for your VSC activities. The course is not a pass or fail course, and it takes 90 minutes and using AUXLMS will automatically record the course. If you've never logged into AUXLMS, here is a link to instructions and video:

Please do not delay if you plan to participate in NSBW activities. If you require additional assistance, please contact your FC or FSO-MT.

-For Coast Guard liability insurance purposes, **PRIOR** to leaving the house for **ANY** VSC activity other than to participate at an organized station, **PLEASE** remember to notify member of the flotilla leadership (FC, VFC, and FSO-VE) of your planned activity. The notification could be in the form of an email, text message or a phone call. In the unlikely event of an incident, be prepared to provide proof of the notification. In addition, per the new VSC Manual please remember, you also need to be in uniform and if boarding a vessel you need to be wearing a lifejacket.

-PLEASE do NOT wear boots to climb aboard a vessel to perform a VSC. Our program allows for deck shoes, white or black tennis/walking with soft soles. If this is not an option, please consider purchasing disposal shoe/boot covers available at any the paint or hardware dept. or at Wal-Mart, Lowes, Home Depot, etc. A package of 6 is typically under \$10.

Did you know that approx. 11% of people are left handed, while 50% of dogs are left handed as well!

Let's work together for our safety and the safety of others by setting an example and wear our lifejackets while performing VSC's especially when working around docks and when climbing aboard large vessels!
